**Fruit Garden** – WWFRF has moved the best varieties from the plum, peach and alternative crops research areas into the fruit garden.

**Cherry Block** – WWFRF will rejuvenate the cherry block by moving in new varieties to test in place of trees which have finished being tested and paying for the maintenance of the new trees. Shirley Kropp motioned that \$1150 be allocated for the renovation of the cherry block. Seconded by Rachel Petrich. Passed. \$1000 has been donated from North Olympic Fruit Club for cherry research.

**Research** – WWFRF is working to have a permanent position filled at Mount Vernon NWREC to support the cider, wine, nursery growers, fruit wine and orchard industries.
